*As per the latest ICAR's Circular No. 33-8/2016 Estt.-I dated 15th September 2016, "the part of Service rendered by the transferred employee prior to his transfer after availing the last promotion in the parent institute shall not be counted for the purpose of his/her promotion to the next higher grade in the new Institute/Headquarters".
